SILPURAN® 2112 A/B can be used as a skin adhesive in medical applications.

## Processing

Components A and B of SILPURAN<sup>®</sup> 2112 A/B are mixed homogeneously in a ratio A : B = 1 : 1 and vulcanise rapidly at temperatures over 100 °C.

SILPURAN<sup>®</sup> 2112 A/B has good adhesive properties that can be adjusted to suit the relevant requirements: Increasing the proportion of component A results in a softer vulcanisate and increased tackiness. Increasing the proportion of component B results in a harder vulcanisate and reduced tackiness.

## Important note:

The platinum catalyst is in component A.

Caution! Only A and B components with the same batch number may be processed together!

#### Storage

The 'Best use before end' date of each batch is shown on the product label.
