Processing

ELASTOSIL[®] R 781/80 may be vulcanized using ELASTOSIL[®] AUX CURING AGENT C1, C6. Due to the high filler content it is recommended to reduce the content of peroxides to 50 % of the normally applied amounts when ELASTOSIL[®] R 781/80 is processed directly.

As an alternative crosslinking system the ELASTOSIL[®] 4K system may be applied. For further information on this topic please contact your responsible sales or technical manager.

The raw rubber requires the addition of peroxides for vulcanization at elevated temperatures. A homogeneous incorporation is a must to maintain best processing behavior. Pot life is depending on the used peroxide and storage condition. Please consider the technical data sheet of the corresponding curing agent.
